

Academic abstract: This paper analyzes the real option framework's capacity for bridging the gap between strategic theory and financial theory. Through a theoretical discussion of the interface between them, it is shown that they have an obvious point of contact, since strategic theory aims at identifying the path to the highest value creation, while the financial discipline of valuation contains tools for appraising the value creation. Nevertheless, it is argued that differences in foci and prerequisites cause a gap. The real option framework is put forward as holding potential for bridging this gap by being applicable to both strategic analysis and financial valuation. Correspondingly, it is suggested that the real option framework contains a strategic and a financial perspective. The paper then moves forward to investigate the perspectives individually in the light of a case analysis in order to be able to conclude on their alignment and the feasibility of quantification (ie valuation) at the end of the paper.
